# Purpose and legal basis for using your information

### Purpose of processing

Caerphilly County Borough Council is required to consult with a number of stakeholders as part of their statutory duty under the Childcare Act, 2006, to produce a Childcare Sufficiency Assessment.

By collecting your data this enhances the ability of Caerphilly County Borough Council to co-ordinate and assess the supply and demand for childcare within the local authority.

#### Legal basis for processing

In order for the processing of personal data to be lawful under the General Data Protection Regulations 2016, a valid condition from Article 6 of the Regulations must be identified, which is outlined below:

We will store your data:

On secure online databases and CCBC servers which are GDPR compliant.

Anonymised data is published on the council's Early Years website and will form part of the Caerphilly Childcare Sufficiency Assessment that is shared with Welsh Government.

If the information you provide is subject to such a request, where possible Caerphilly County Borough Council will consult with you on its release. If you object to the release of your information we will withhold your information if the relevant legislation allows.

# **Details of retention period**

Anonymised consultation responses will be held on secure council servers for up to 2 years. Anonymised data analysed from consultation responses will form part of the final report.
