Description of Privacy Notice:To advise users regarding how information will be

collected and stored to enable access to CCBC EV

charging infrastructure for private vehicles.

How we will use your information

Purpose and legal basis for using your information

Purpose of processing

The information will be collected to allow CCBC staff and visitors to access to CCBC electric vehicle charging infrastructure for charging private vehicles. Contact information is collected in case vehicles using EV charging bays need to be moved.

Legal basis for processing

We are relying on the provisions of Data Protection to process your information as detailed below:

In order for the processing of personal data to be lawful under the General Data Protection Regulations 2016, a valid condition from Article 6 of the Regulations must be identified, which is outlined below:

1(f)processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child.

If the information you provide is subject to such a request, where possible Caerphilly County Borough Council will consult with you on its release. If you object to the release of your information we will withhold your information if the relevant legislation allows.

How long will we retain your information

Details of retention period

How long Caerphilly County Borough Council retains information is determined through statutory requirements or best practice.

The information will be retained for as long as the individual requires access to the infrastructure or until they request it is removed. We will check every 12 months whether you still require access to the system and will remove your information if not.
