## Caerphilly Station Footbridge

### Temporary Footbridge Order 2023

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit pedestrians from proceeding along

Caerphilly Station Footbridge, Caerphilly Park & Ride.

The proposed Order is expected to commence on 28th July 2023 for a period not exceeding six months or until the works have been completed, whichever is the earlier.

Access for pedestrians will not be maintained.

Alternative routes are via King Edward Avenue, Cardiff Road, Station Road.

The reason for making the Order is to allow for essential repairs to footbridge.

The order is required by Caerphilly County Borough Council.
