## **Temporary A467 30mph Speed Limit Order 2023**

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to introduce a 30MPH speed limit along the A467 between Full Moon roundabout, Crosskeys and Pontymister roundabout, Risca for a distance of approx. 3.60km.

The proposed Order is expected to commence on 19th June 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 25th August 2023.

The reason for making the Order is to facilitate safe vehicular passage through the contraflow. The reason for the contraflow is to create a safe environment to undertake bridge deck waterproofing and expansion joint replacement to Dan-Y-Graig Underbridge.

The Order is required by Caerphilly County Borough Council.
