Proposed Provision and Amendments to Traffic Orders at Various locations within the Gilfach, Penyrheol and Twyn Carno Wards in Caerphilly County Borough

NOTICE is hereby given that Caerphilly County Borough Council in exercise of their powers under the Road Traffic Regulation Act 1984 and all other enabling powers and after consulting with the Chief Officer of Police have made an order the effect of which is: -

The order will be to prohibit waiting at any time in order to improve safety, reduce congestion and aid public transport on the following lengths of road within the Gilfach, Penyrheol and Twyn Carno Wards:

- Cross Street, Gilfach
- Gelli'r Felin, Caerphilly
- Ffordd y Maes, Caerphilly
- Cae'r Fferm, Caerphilly
- White Cross Lane, Caerphilly
- Heol Aneurin and Pen-y-Groes, Penyrheol, Caerphilly
- Ogmore Court and Harlech Court, Hendredenny, Caerphilly
- Lane to rear of Church Street, (Alexandra Place), Rhymney

The Order shall come into operation on
31/07/2023

If you wish to question the validity of the Order or of any of the provisions in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 on the grounds that any requirement of that Act made under it has not been complied with in relation to the Order you may within six weeks of the date hereof apply to the Court for this purpose
