- Tredegar Street, Rhisga

(Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2019 (Amendment Order No 27) 2023

Revocation and Amendments to Traffic Orders at Various Locations within Caerphilly County Borough to provide 'Parklets'

NOTICE is hereby given that Caerphilly County Borough Council in exercise of their powers under the Road Traffic Regulation Act 1984 and all other enabling powers and after consulting with the Chief Officer of Police have made permanent an experimental Order an Order the effect of which is: -

To revoke existing restrictions and prohibit waiting at any time and provide parking bays for disabled badge holders to create safe outside dining spaces for hospitality businesses to create an outdoor café culture in the town centres at the following locations:

- Hanbury Road, Bargoed,
- Upper High Street Bargoed,
- High Street, Blackwood,
- Clive Street, Caerphilly,
- Victoria Terrace, Newbridge,
- Tredegar Street, Risca

The Order shall come into operation on 24th April 2023.

If you wish to question the validity of the Order or of any of the provisions in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 on the grounds that any requirement of that Act made under it has not been complied with in relation to the Order you may within six weeks of the date hereof apply to the Court for this purpose.
