(Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2019 (Amendment Order No 30) 2024

Proposed provision of a 24hr Rural Clearway Traffic Order, Fochriw Road near Trecatti landfill site

NOTICE is hereby given that Caerphilly County Borough Council (the 'Council') in exercise of their powers under the Road Traffic Regulation Act 1984 (the '1984 Act') and the Traffic Management Act 2004 (the '2004 Act') and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act propose to make an Order the effect of which is to amend the Caerphilly County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2019 by the following:

Fochriw Road near the Trecatti Landfill site

- The provision of a 24 hr Rural Clearway Traffic Order on Fochriw Road from a point 25m southeast of the cattle grid to the southeast of the junction of Rhymney Common Road and Fochriw Road in a southerly direction to a point 15m northwest of the next cattle grid on Fochriw Road, a distance of approximately 1,787m (1.1 miles)
