# How we will use your information

## Purpose and legal basis for using your information

#### **Purpose of processing**

Each local authority in Wales is responsible for providing concessionary travel cards to individuals eligible to receive them.

The administration of concessionary travel cards will also be carried out on an all-Wales basis by Transport for Wales, which is owned by Welsh Government and has responsibility for transport matters in Wales. For further information on how Transport for Wales will use your information, please follow this link to their Privacy Notice.

When you use your concessionary travel card on a bus, the bus operator will collect card details, which will be shared with us and Transport for Wales, to enable the bus operator to be paid for your journey via an automatic card reader.

#### Legal basis for processing

In order for the processing of personal data to be lawful under the General Data Protection Regulations 2016, a valid condition from Article 6 of the Regulations must be identified, which is outlined below:

Art 6 1e. processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller;

Data Protection legislation provides extra protection for certain classes of information called 'special category personal data'. If any information falls within the definition of special category personal data then an additional condition from Article 9 of the Regulations must be identified, as outlined below:

#### Data Protection Act 2018 - Schedule 1 / Part 2

- 6 (1) This condition is met if the processing—
  - (a) is necessary for a purpose listed in sub-paragraph (2), and
  - (b) is necessary for reasons of substantial public interest.
  - (2) Those purposes are—
    - (a) the exercise of a function conferred on a person by an enactment or rule of law:
    - (b) the exercise of a function of the Crown, a Minister of the Crown or a government department.

Statistical information were individuals cannot be identified may be shared with Welsh Government, who grant fund the concessionary travel scheme.

When you use your concessionary travel card on a bus, the bus operator will collect card details, which will be shared with us and Transport for Wales, to enable the bus operator to be paid for your journey via an automatic card reader.

We may also share your information with other local transport authorities (who are also the statutory operators of the concessionary travel scheme) if you were to move to another local authority area.

We may contact and share information with your Health Service provider (e.g. GP, Consultant) for the purpose of verifying disability information you provide on your application form.

#### Details of any external data processors

Transport for Wales employ data processors, which provide, customer service, IT, identity checking and system administration services.

#### **Requests for information**

All recorded information held by Caerphilly County Borough Council may be subject to requests under the Freedom of Information Act 2000, Environmental Information Regulations 2004 and Data Protection legislation.

If the information you provide is subject to such a request, where possible Caerphilly County Borough Council will consult with you on its release. If you object to the release of your information we will withhold your information if the relevant legislation allows.

## How long will we retain your information

#### **Details of retention period**

How long Caerphilly County Borough Council retains information is determined through statutory requirements or best practice.

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

Due the nature of the service provide we will retain your information until you no longer need this service .
