COUNCIL GARAGE ALLOCATION POLICY

GARAGE WAITING LIST RULES

- Applicants must be 18 years of age or over.
- Applicants will be registered on a waiting list and garages allocated in date order.
- Applicants are permitted to select any garage site within the locality of the vehicle owner's address or the vehicle's registered address.

GARAGE LETTINGS RULES

- Garage tenancies are restricted to one tenancy per person but more than one tenancy per household is permitted.
- Preference will be awarded to those persons on the garage waiting list who have a substantiated mobility dependency (including their family/carer who directly transports them by car) as authorised by the Area/Neighbourhood Housing Manager.
- Garage tenants wishing to transfer to another garage may register on the waiting list immediately after their tenancy has begun.
- Applicants with a housing debt will not be offered a garage tenancy until the debt is cleared.
- Garage tenants whose garages become unusable through disrepair, which is the council's responsibility, will be offered the next available garage on the same or nearest site in preference to applicants registered on the waiting list.'
- Tenants wishing to exchange their garage with another tenant will be permitted to do so subject to the written approval of the Housing Manager.
- Transfer of the tenancy to the spouse upon the death of the tenant is permitted subject to the written approval of the Housing Manager. A new tenancy will be issued.
- Assignments of garage tenancies are not permitted in any circumstances (for example, transfer of tenancy to a friend or relative).
- Tenants of flat/maisonettes directly above a garage to be given first refusal of the garage when available for letting and where possible to be allocated with the property when the property is relet.
- The Area/Neighbourhood Housing Manager has the authority to allocate any garage outside these rules depending on the exceptional circumstances of any applicant.
- A copy of the vehicle registration document must be provided at the time of offer of any garage tenancy.
- The garage must be used only for the purpose of housing a private motor car, motorcycle or cycle.

GARAGE REFUSAL RULE

- Reason for refusal of garage tenancy to be confirmed in writing by the applicant.
- Applicants who refuse a second offer of a garage tenancy or do not respond to an offer will be removed from the waiting list and will be required to make a new application to re-register.
