HYSBYSIR drwy hyn fod Cyngor Bwrdeistref Sirol Caerffili, wrth weithredu ei bwerau o dan Ddeddf Rheoleiddio Traffig Ffyrdd 1984 (fel y'i diwygiwyd), yn bwriadu, mewn nid llai na saith diwrnod o ddyddiad yr Hysbysiad hwn, wneud Gorchymyn a fydd â'r effaith o wahardd cerbydau rhag mynd ar hyd:-

Park Lane, Caerffili, o gefn D. J. Thomas & Son i'r gyffordd â B4263 Cardiff Road. Atal traffig unffordd o'r gyffordd â Crescent Road i'r man cau er mwyn caniatáu mynediad i eiddo ac allan ohono.

Disgwyllir i'r Gorchymyn arfaethedig gychwyn ar 10 Ionawr 2022 am gyfnod nid yn fwy na deunaw mis neu hyd nes bod y gwaith wedi ei gwblhau, p'un bynnag sydd gynharaf. Disgwyllir i'r gwaith gael ei gwblhau erbyn 7 Chwefror 2022.

Bydd llwybr arall ar gael ar hyd St Fagans Street.

Park Lane, Caerphilly Temporary Prohibition of Driving and Suspension of One-Way Traffic Order 2022

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:-

Park Lane, Caerphilly from the rear of D. J. Thomas & Son to its junction with B4263 Cardiff Road. Suspension of one-way traffic from Crescent Road junction to the point of closure to allow access to and egress from properties.

The proposed Order is expected to commence on 10th January 2022 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated that the works will be completed by 7th February 2022.

An alternative route will be available via St Fagans Street.

The reason for making the Order is to allow for demolition works adjacent to Park Lane.

The Order is required by Caerphilly County Borough Council.
