Temporary Prohibition of
Driving Order 2021**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:-

Twyn Gwyn Road at its junctions with Ty-Llwyd and Quarry Cottages.

The proposed Order is expected to commence on Monday 21st June 2021 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated that the works will be completed by Monday 5th July 2021.

Emergency service vehicles and resident access and pedestrian will not be maintained.

An alternative route will be available via signed local roads.

The reason for making the Order is to allow for drainage channel maintenance.

The Order is required by Caerphilly County Borough Council.
