## Temporary Prohibition of Driving Order 2023

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along

National Road, Cilfynydd from Lili Wen Farm for a distance of approx. 1km in a westerly direction.

The proposed Order is expected to commence on 1st August 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be completed by 31 August 2023.

Access for emergency services and residents will not be maintained. Pedestrian access will be maintained.

Alternative routes are via signed diversion route.

The reason for making the Order is to allow for culvert maintenance works.

The Order is required by Caerphilly County Borough Council.
