## FOOTPATH 88 MYNYDDISLWYN

### TEMPORARY PROHIBITION OF PEDESTRIANS ORDER 2024

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians from proceeding along:

That section of Footpath Number 88 Mynyddislwyn.

The alternative route for pedestrians will be available via the local highway network.

The temporary order will be effective from 20 May 2024 up to a maximum duration of six months or until the works are completed. It is anticipated that the works will be completed by 21 June 2024.

The closure is required by Lovell.

The reason for making the Order is to allow for construction works on land adjacent to footpath.
