## **TEMPORARY PROHIBITION OF DRIVING ORDER 2024**

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along Herbert Terrace, Hafodyrynys from its junction with A472 and Cefn-Crib Road for a distance of 40 metres.

The proposed Order is expected to commence on 3 June 2024 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be complete by 14 June 2024.

Access for emergency services and pedestrians will be maintained. Access to Hafodyrynys Inn will be maintained.

HGV alternative routes are via A472 East, u turn at the roundabout, A472.

The reason for making the Order is to allow for drainage works.

The order is required by Caerphilly County Borough Council.
