**TEMPORARY PROHIBITION OF
DRIVING ORDER 2023**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Llanerch Lane, Trinant, for a distance of approx. 220 metres in an easterly direction from Pentwyn Road junction.

The proposed Order is expected to commence on 6 November 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be completed by 24 November 2023.

Access for emergency services and pedestrians will be maintained.

Alternative routes are via the signed diversion route.

The reason for making the Order is to allow for works in the carriageway.

The order is required by Caerphilly County Borough Council.
