Disgwylir i'r Gorchymyn arfaethedig gychwyn ar 13 Tachwedd 2023 am gyfnod nid yn fwy na deunaw mis neu nes bod y gwaith wedi ei gwblhau, p'un bynnag sydd gynharaf. Disgwylir i'r gwaith gael ei gwblhau erbyn 26 Tachwedd 2023.

Temporary Prohibition of Driving Order 2023

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

High Street, Nelson, from its junction with High Close for a distance of approx. 160 metres in a westerly direction.

The proposed Order is expected to commence on 13 November 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is anticipated the works will be completed by 26 November 2023.

Access for emergency services and residents will not be maintained. Pedestrian access will be maintained.

Alternative routes are via High Street, B4255 Commercial Street, B4255 Dynevor Terrace, A472 Mafon Road, Llwynycelyn Terrace, High Street.

The reason for making the Order is to allow for manhole construction in the carriageway.

The order is required by Forest Traffic Services.
