Darparu llinellau melyn dwbl ar Commercial Street, Senghenydd

(Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2019 (Amendment Order No 32) 2024

Proposed Provision and Amendments to Traffic Orders at Various locations within the Aber Valley, Aberbargoed and Bargoed, New Tredegar and Penyheol Wards

NOTICE is hereby given that Caerphilly County Borough Council (the 'Council') in exercise of their powers under the Road Traffic Regulation Act 1984 (the '1984 Act') and the Traffic Management Act 2004 (the '2004 Act') and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act propose to make an Order the effect of which is to amend the Caerphilly County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2019 by the:

Provision of Double Yellow Lines (DYLs) at Commercial Street, Senghenydd

- On the eastern side of Commercial Street from its junction with the lane connecting Commercial Street to Stanley Street, in a northerly direction to the northern boundary of the garage, a distance of approximately 46m.
- On the eastern side of Commercial Street from its junction with the lane connecting Commercial Street to Stanley Street, in a southerly direction to the common boundary of Nos 2 / 4 Commercial Street, a distance of approximately 9m.
- On the southern side of the lane connecting Commercial Street to Stanley Street, from its junction with the Commercial Street in a northeasterly direction for a distance of approximately 6m.

Removal of No Waiting restriction 9am – 6pm at School Street, New Tredegar

- On the southwestern side of School Street from the northwestern boundary of No 2 School Street in a southeasterly direction to the northwestern boundary of No 12 School Street, a distance of approximately 30m

Removal of existing waiting restrictions and provision of 2 extra limited waiting bays Mon-Sat

8am-8pm for 1 hour and no return within 1hour and change existing limited waiting bay to Mon-Sat 8am-8pm for 1 hour and no return within 1hour and provision of DYLs at St Cenydd Road, Tredegar, Caerffili

- Remove existing limited waiting bay Mon-Sat 8am-6pm for 30mins on the northeastern side of St Cenydd Road from the northwestern building edge of No 104 St Cenydd Road in a southeasterly direction for a distance of approximately 13m and replace with a limited waiting bay Mon-Sat 8am-8pm for 1 hour and no return within 1hour for a distance of approximately 13m.
- Remove existing limited waiting restrictions and replace with limited waiting bay Mon-Sat 8am-8pm for 1 hour and no return within 1hour on the northeastern side of St Cenydd Road from the northwestern building edge of No 106 (Vets) St Cenydd Road in a southeasterly direction for a distance of approximately 7m
- Remove existing limited waiting restrictions and replace with limited waiting bay Mon-Sat 8am-8pm for 1 hour and no return within 1hour on the northeastern side of St Cenydd Road from the northwestern boundary of No 100 St Cenydd Road in a southeasterly direction for a distance of approximately 12m
- Remove existing limited waiting restrictions and replace with DYLs on the northeastern side of St Cenydd Road from the northwestern building edge of No 104 St Cenydd Road in a northwesterly direction for a distance of approximately 4m
- Remove existing limited waiting restrictions and replace with DYLs on the northeastern side of St Cenydd Road from the northwestern building edge of No 100 St Cenydd Road in a northwesterly direction for a distance of approximately 4m

Provision of DYLs at William Street and Ty Fry Road, Aberbargoed

- On the southwestern side of Ty-Fry Road from its junction with William Street in a southeasterly direction for a distance of approximately 10m
- On the southwestern side of Ty-Fry Road from its junction with William Street in a northwesterly direction for a distance of approximately 5m
- On the northwestern side of William Street from its junction with Ty-Fry Road in a southwesterly direction for a distance of approximately 10m
- On the southeastern side of William Street from its junction with Ty-Fry Road in a southwesterly direction for a distance of approximately 10m
