- Railway Terrace ac Islwyn Street, Abercarn

**(Prohibition and Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2019  
(Amendment Order No 10) 2023**

**Proposed Provision and Amendments to Traffic Orders at Various locations within the Abercarn Ward in Caerphilly County Borough**

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of their powers under the Road Traffic Regulation Act 1984 and all other enabling powers and after consulting with the Chief Officer of Police have made an Order the effect of which is: -

The Order will be to prohibit waiting at any time in order to improve safety, reduce congestion and aid public transport on the following lengths of road within the Abercarn Ward:

- Bernard Street and Caradoc Street, Cwmcarn
- Ffrwd Melin (Mill Race), Abercarn
- High Meadow, Abercarn
- Nantcarn Road (Reece's Terrace) and Craig View Bungalows, Cwmcarn
- Access Road off High Street serving Garn Street, Abercarn
- Newport Road, Cwmcarn
- Railway Terrace and Islwyn Street, Abercarn

The Order shall come into operation on 14 June 2023.

If you wish to question the validity of the Order or of any of the provisions in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 on the grounds that any requirement of that Act made under it has not been complied with in relation to the Order you may within six weeks of the date hereof apply to the Court for this purpose.
