Disgwylir i'r Gorchymyn arfaethedig gychwyn ar 30 Ionawr 2023 am gyfnod nid yn fwy na deunaw mis neu nes bod y gwaith wedi ei gwblhau, p'un bynnag sydd gynharaf. Disgwylir i'r gwaith gael ei gwblhau erbyn 24 Mawrth 2023.

## Eglwysilan, Abertridwr Temporary Prohibition of Driving Order 2023

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Eglwysilan, Abertridwr from its junctions with Groeswen Road in a northerly direction for a distance of approximately 870 metres.

The proposed Order is expected to commence on 30 January 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is expected the works will be completed by 24 March 2023.

Access for resident and emergency service vehicles will not be maintained. Pedestrian access will be maintained.

Alternative routes are via Old Navigation Road, Heol Y Bwensi, Ffynnonbwla Road.

The reason for making the Order is to allow for installation of fibre optic cable.

The Order is required by National Grid Telecoms.
