**Temporary Prohibition of
Pedestrians Order 2023**

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians from proceeding along:

That section of Footpath Number 1, Llanfedw, Draethen.

The alternative route for pedestrians will be available via the local highway network.

The temporary order will be effective from 13th April 2023 up to a maximum duration of six months or until the works are completed, whichever is the earlier. It is anticipated that the works will be completed by 13th October 2023.

Access for Emergency Services and pedestrians will not be maintained.

The closure is required by Caerphilly County Borough Council.

The reason for making the Order is due to adjacent unsafe wall of Ruperra Castle
