**Temporary Prohibition of  
Pedestrians Order 2023**

**NOTICE** is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order the effect of which will be to prohibit pedestrians from proceeding along:

That section of Footpath Numbered 176 and 178 Risca.

The alternative route for pedestrians will be available via the local highway network.

The temporary Order will be effective from 7 February 2023 to a maximum duration of six months or until the works are completed, whichever is the earlier. It is anticipated the works will be completed by 28th February 2023.

The closure is required by Caerphilly County Borough Council.

The reason for making the Order is to allow for desilting works.
