Notice of intention to apply to stop up the highway at CHERRY ORCHARD, GORDON CLOSE, BLACKWOOD

NOTICE is given that Caerphilly County Borough Council as Highway Authority for the County Borough of Caerphilly intends to apply to Gwent Magistrates' Court sitting at Cwmbran Magistrates' Court on 8th September 2022 at 2:00pm for an Order under section 116 of the Highways Act 1980 authorising the stopping up of an area of the highway to the west of Gordon Close, Blackwood shown shaded red on the attached plan (Plan) on the ground that the highway is unnecessary. The effect of the Order will be to extinguish all public rights of way over the said land.

A copy of the draft Order and Plan may be inspected free of charge at the Council Offices at Penallta House, Tredomen Park, Ystrad Mynach, Hengoed, CF82 7PG between the hours of 9am and 5pm Monday to Thursday and 9am and 4.30pm Friday (excluding bank holidays and public holidays) or on the Council's website at www.caerphilly.gov.uk.

Any person to whom this Notice has been given or who uses the highway specified or who would be aggrieved by the making of the Order may appear before the Magistrates' Court to raise an objection or make a representation on the application. Any person intending to appear before the Magistrates' Court at the hearing of the application is requested to inform the Council's Legal Services Department at Penallta House, Tredomen Park, Ystrad Mynach, Hengoed, CF82 7PG before 2nd September 2022 quoting reference Legal/MW/GordonClose.

HIGHWAYS ACT 1980 - SECTION 116

BEFORE the Magistrates' Court sitting at Cwmbran Magistrates' Court, Tudor Road, Cwmbran, NP44 3YA

APPLICATION having been made by Caerphilly County Borough Council (the Applicant) under section 116 of the Highways Act 1980 that an area of the highway known as Cherry Orchard, Gordon Close, Blackwood and shown shaded red on the Plan attached to this Order should be stopped up on the ground that it is unnecessary.

AND the Court being satisfied that the Applicant has given the notices required by Part 1 of Schedule 12 to the Highways Act 1980 and that the written consent of every person having a legal interest in the land over which the highway is to be diverted has been obtained AND the Court having heard the Application.

AND the Court being satisfied that the said area of highway is unnecessary.

IT IS HEREBY ORDERED that the said area of highway be authorised to be stopped up for the purposes of all traffic.
