Effaith gyffredinol y Gorchymyn fyddai:

Cyfyngu ar barcio ar y stryd i ddeiliaid bathodyn glas yn unig mewn cilfach wedi'i marcio'n glir ar y briffordd, yng nghyffiniau'r eiddo a nodir isod:

- Coed-y-Pica, (am 8 Bronmynydd), Abertridwr
- 13 Park Street, Crosskeys

Mae hefyd yn fwriad i ddiddymu'r manau parcio i bobl anabl yn y cyfeiriadau canlynol:

- 47 Jamesville, Cwmcarn
- 2 Beecher Terrace, Crosskeys
- 120 North Road, Pont-y-waun

**Proposed Provision and Removal to Disabled
Persons Parking Places at Various locations within
Caerphilly County Borough**

STATEMENT OF GENERAL EFFECT

The general effect of the Order would be:

To restrict on-street parking to blue badge holders only in a clearly marked out bay on the highway, in the vicinity of the properties indicated below:

- Coed-y-Pica (for 8 Bronmynydd), Abertridwr
- 13 Park Street, Crosskeys

It is also proposed to revoke the disabled persons parking places at the following addresses:

- 47 Jamesville, Cwm-carn
- 2 Beecher Terrace, Crosskeys
- 120 North Road, Pont-y-waun

STATEMENT OF REASONS

The Council considers that the Order to provide on-street parking bays would assist disabled persons by making a parking space available near their home in a road where extensive on-street parking occurs.

The Council considers that the Order to remove existing, redundant on-street parking bays, where the need no longer exists, would provide additional unrestricted parking to other residents in the area.
