Temporary Prohibition of Driving Order 2023

NOTICE is hereby given that Caerphilly County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends in not less than seven days from the date of this Notice to make an Order, the effect of which will be to prohibit vehicles from proceeding along:

Unnamed Lane, Cwmalsie, Pontllanfraith from its junction with Sirhowy View and the access road to Tris Coed Farm for a distance of approximately 560 metres.

The proposed Order is expected to commence on 30 January 2023 for a period not exceeding eighteen months or until the works have been completed, whichever is the earlier. It is expected the works will be completed by 10 February 2023.

Alternative routes are via Unnamed Lane, Tywngwyn Road, Maindee Road, B4251, Glenview Terrace, Unnamed Lane.

The reason for making the Order is to allow for laying of new duct.
